Former sexystar **Rosanna "Osang" Roces** started the New Year with a big bang. After so many years of silence and away from the limelight, here she comes exploding like a bomb, impacting so many people and landing her in premium newspaper pages.

Osang was responsible for the 20-day suspension of the pre-noon show, "Showtime," served early this week by the Movie and Television Review and Classification Board (MTRCB).

The MTRCB sentence followed Osang's tactless off-the-cuff remarks that undermined the teaching skills of a Showtime contestant's mentors in his school in Calamba, Laguna. The question posed the contestant was about the origin of the name of the country's national hero, Jose Rizal, a native of Calamba. Not knowing the answer, the contestant got a mouthful from Osang, in Tagalog: "You must berate your teacher for not teaching you the answer to that question. Teachers like those are pathetic; they don't preach the good and the truth. And to think you are from Calamba, too."

The remarks enraged the country's teaching sector, which is now demanding a public apology from Osang. Although Osang has been reported to have privately apologized to her co-host, Vice Ganda, and the management of Showtime itself, she allegedly has no intentions of doing so publicly. In a text message she reportedly sent a news program, she said she was just exercising her right to free speech.
